D	10.4.2 –	Shot struck ground within 3m (9'-9") of competitor not engaging close target
D	10.4.3 –	Discharge prior to or during loading, reloading, unloading, or showing clear
D	10.4.4 –	Discharge while clearing a malfunction
D	10.4.5 –	Discharge while transferring handgun between hands
D	10.4.6 –	Discharge during movement while not engaging targets
D	10.4.7 –	Engaged steel within 7 meters
D	10.5.1 –	Handling a gun outside of a safety area (2.4.1) or on the line w/o RO direction (8.3.1)
D	10.5.2 –	Muzzle pointed uprange/broke 180 after start signal, loaded or otherwise
D	10.5.3 –	Dropped handgun during course of fire, loading, or unloading; loaded or not
D	10.5.4 –	Holstered or un-holstered within a tunnel
D	10.5.5 –	Swept self during course of fire ( <u>not</u> while drawing or reholstering)
D	10.5.6 –	Violated 3'-3" rule during draw or re-holstering
D	10.5.7 –	Wearing or using more than one handgun during a COF
D	10.5.8/5.7.2 –	Finger in trigger guard while clearing a malfunction and not aiming at targets
D	10.5.9/8.4.1 –	Finger in trigger guard while loading or unloading
D	10.5.10/8.5.1 –	Finger in trigger guard while moving and not addressing targets
D	10.5.11 –	Holstered gun in an unsafe condition
D	10.5.12 –	Handling ammunition, dummy rounds, empty cases, snap caps, or loaded magazines in a Safety Area
D	10.5.13 –	In possession of a loaded gun not on the line under RO control
D	10.5.14 –	Retrieved a dropped handgun
D	10.6 –	Un-sportsmanlike conduct (including <u>deliberately</u> shooting through props, and/or failure to obey course and/or verbal instructions/warnings)
D	10.6.3/5.4.5 –	<u>Deliberately</u> displaced or removed ear and/or eye protection during COF
D	10.7 –	Under the influence/impaired abilities
